# Pay Circular (M&D) 5/2008

Pay and conditions for hospital medical and dental staff and doctors and dentists in public health, the community health service and salaried primary dental care (England)

- To: All NHS employers (England) for action
- Cc: 4 UK Health Departments for information/action

## Summary

This pay circular informs NHS employers of the introduction of new mileage rates for hospital medical and dental staff and doctors and dentists in public health, the community health service and salaried primary dental care.

## Agreement

1 Revised mileage rates have been agreed for hospital medical and dental staff and doctors and dentists in public health, the community health service and salaried primary dental care.

#### Mileage rates

- 2 NHS Employers and the BMA have agreed that mileage rates for hospital medical and dental staff and doctors in public health medicine and the community health service will be adjusted in line with agreements reached in Staff Council where these are more advantageous. Previous rates that were higher than those in the current agreement will be held at their earlier value.
- 3 NHS Employers and the BDA have agreed that mileage rates for dentists employed in the salaried primary dental care services will be as set out in Annex L of the NHS Terms and Conditions of Service Handbook as updated from time to time.

## Action

- 4 The attached Section 6 of Annex A to Appendix I of the terms and conditions of service for Hospital Medical and Dental staff and Doctors in Public Health Medicine and the Community Health Service replaces that previously published as part of Pay Circular (M&D) 3/2008. Employers should ensure that local documentation is amended accordingly.
- **5** A copy of Annex L to the NHS Terms and Conditions of Service Handbook is attached for reference.
- 6 The revised rates are effective from 1 July 2008. Employers should make arrangements where necessary to ensure that the appropriate rates are paid from that date.
- 7 Other Health Departments should ensure that where applicable their local documentation reflects the changes detailed here.
- 8 A High Court judgment in 2006 highlighted the need for NHS employers to take all reasonable steps to ensure that the effects of nationally negotiated collective agreements are incorporated into individual contracts of employment.
