

## Updates, additions and reviews to nursing and midwifery national job profiles

Date	Description
January 2020	Minor changes of wording to some profiles. No changes to factor levels
July 2019	Nursing Services and Nursing Community profiles have been archived and profiles in the Nursing Combined job family augmented by adding Team Leader (b6, NS), Team Leader (Learning Disabilities) (b6, NC), Nurse Consultant (b8a-c, NS) and Nurse/Midwife Consultant Higher Level (b8c-9, NS), as these profiles were not used in the Combined version. Nursing/Midwife Consultant Higher Level also placed in the Midwifery sub group of profiles.
June 2019	New profiles added to the theatre nurses suite as follows: <ul style="list-style-type: none"> <li>• Theatre nurse/practitioner – band 5</li> <li>• Theatre nurse/practitioner higher level – band 6</li> </ul>
December 2018	Health visitor specialist – changes to factor 2 knowledge training and experience.  Changes from: <b>Highly developed specialist knowledge, underpinned by theory and experience</b> – professional knowledge acquired through degree/diploma in nursing supplemented by specialist training to become HV, plus further specialist knowledge e.g. in needs of specific client group acquired training experience to master’s equivalent level – JE level 7  Changed to: <b>Highly developed specialist knowledge, underpinned by theory and experience</b> – professional knowledge acquired through degree supplemented by post graduate diploma specialist training, experience, short courses plus further specialist training to masters equivalent level – JE level 7 (remains unchanged).
August 2018	Nursing/health visitor specialist (community practice teacher) minor changes to the knowledge, training and experience non-bold statement as follows: ‘to masters level or equivalent’ has been added after ‘professional knowledge’ and ‘plus community practice teaching training’ has replaced ‘and community practice teaching training’.
April 2013	Combined nursing profiles - these can be used alongside the existing published nursing profiles and draw attention to the consultant

	profiles in nursing services and the professional manager profiles in 'other'.
